There are different ways you can talk to the Royal Commission into Institutional Responses to Child Sexual Abuse and assist its investigations. For example, you might be able be able to:

- give a written statement
- attend a private session with a Commissioner (if you are already registered)

If you are unsure what to do or if you want more information or help, you can contact knowmore.

What is the Royal Commission about?

The Royal Commission is looking into Australian institutions: how child sexual abuse happened 'on their watch' and whether they responded the best they could.

What will the Royal Commission do?

The Royal Commission will hear from people who experienced child sexual abuse in institutions and will call witnesses, like organisations and survivors, to give evidence in public hearings. If you want to know more, you can read **knowmore**'s factsheet About the Royal Commission.

How do I let the Royal Commission know I want to tell my story?

How will the Royal Commission hear my story?

There are a number of ways you can tell your story to the Royal Commission.

You could make a written or oral statement, or speak to a Commissioner in a private session if you were registered before 30 September 2016.

Written statements

You can write down or type what you want to tell the Royal Commission and then send it to them. **This must be sent by 15 November 2017.** You don't have to put your name on a statement, but you should say in your statement that you don't want to give your name.

Private Sessions (if you are already registered)

In a private session, you will tell your story to one or two Commissioners. There is no-one there from the institution you are talking about. The Commissioners may ask you some questions. You cannot have a lawyer represent you but you can have a support person present with you.

The information you give in a private session is not evidence before the Royal Commission and cannot be used in other civil or criminal proceedings. The information you provide to the Royal Commission will be kept confidential unless you agree to it being made public. The exception to this is where there is a risk of harm to someone.
