Can I get compensation? Northern Territory

If you experienced childhood sexual abuse, you may be able to get compensation. Compensation can recognise the wrongdoing done to you and help you to recover money.

What are my compensation options?

In the Northern Territory, the compensation options for survivors of childhood sexual abuse may include:

- crime victims assistance
- criminal court compensation
- a civil claim
- an institutional redress scheme
- the National Redress Scheme.

Crime victims assistance

You may be eligible for crime victims assistance, including payments and free counselling. Usually you have 2 years from when the violent act or injury happened to apply for crime victims assistance. If it has been longer than 2 years, you may still be able to apply in some circumstances.

Criminal court compensation

If there is a criminal prosecution against the person who injured you and they are found guilty of the crime, the court may make an order for them to pay you compensation.

If you want a compensation order, let the prosecutor know.

Civil claims

A civil claim is where you 'sue' the person and/ or institution responsible for your injuries.

There is no time limit for making a civil claim for child sexual abuse in the Northern Territory.

Civil claims are complicated and knowmore can help you find a lawyer with relevant experience.

Institutional redress scheme

Some institutions offer a type of compensation for abuse committed by their staff via an 'institutional redress scheme'. These schemes may make a payment and provide other support, such as counselling.

National Redress Scheme

The Australian Government established the National Redress Scheme for survivors of institutional childhood sexual abuse that occurred prior to 1 July 2018.
