

What to do if you are disappointed with your National Redress Scheme offer

knowmore provides free legal advice and support to survivors of institutional child sexual abuse. If you have received an offer from the National Redress Scheme, we can help you consider your options.

Receiving an offer

Once you receive an offer you have limited time to decide how to respond before the offer expires. The offer expiry date can be found on the first page of your offer letter.

Once you receive an offer you can:

- Accept or decline the offer
- Request a review
- Apply to have the decision revoked.

If you accept or decline your offer you will not be able to apply to review or revoke your offer.

You should seek free legal advice from knowmore before making a decision.

Accepting the offer

If you are disappointed with your offer you do not have to accept it. You should seek legal advice.

Accepting an offer from the National Redress Scheme means giving up your right to continue or start any legal proceedings against

the responsible institution(s). It is important that you consider this very carefully before you make a decision.

Declining the offer

If you decline your offer you will not receive any redress payment, counselling or direct personal response through the National Redress Scheme.

If you do not respond before the offer expires, the offer will be automatically declined.

You can only make one application to the Scheme, if you decline or fail to respond you will not be able to re-apply.

Reviewing the offer

If you do not agree with the decision of the National Redress Scheme you can request a review of your offer in writing or via calling the National Redress Scheme. The Scheme must receive your request prior to the offer expiring.

The review will be carried out by a different Independent Decision Maker who cannot consider new information. Possible outcomes are:

- The original offer is reconfirmed
- You receive a lower offer
- You receive a higher offer.

Please call knowmore for free legal advice before making an application for review.

Revoking the offer

If you do not agree with the decision of the National Redress Scheme **and you have significant additional information** about the abuse you suffered that was not included in your application, you may be able to apply to have the Scheme's decision revoked (withdrawn).

If you are successful, the Scheme will reconsider your application including the additional information before making a new decision.

If your application for revocation is refused, the original decision will apply.

When applying for revocation you need to make sure you do not miss your offer expiry date.
