A Message from Our CEO: Walking with Survivors, Building a Better Future

Welcome to the first edition of Knowmore's newsletter. It is lovely to have you amongst our community.

At Knowmore, we believe justice should be a path to healing, not another source of trauma. Every day, our multidisciplinary teams provide free, trauma-informed, and culturally safe legal support to survivors of childhood abuse.

Since 2013, we have supported over 140,000 survivors of child sexual abuse and members of the Stolen Generations. Many survivors tell us we are the first place they've disclosed their abuse. We hold this trust with deep responsibility.

Demand for our services continues to grow, unsurprising given that more than 1.4 million Australians were sexually abused before the age of 15. We are working to better support young people, incarcerated clients, and those living with complex trauma.

Key highlights over recent months include the launch of our Strategic Plan and the opening of our Perth office after a move from the city out to East Perth.

Survivors are at the heart of everything we do, and that is why the opening of this new



office was such a meaningful milestone. It was officially opened by Stolen Generations survivor and retired magistrate, Sue Gordon AM, and child abuse survivor and advocate, Kirsty Pratt OAM. Their strength, leadership and advocacy continue to inspire us.

We launched our new Strategic Plan at the MCG in Melbourne. The plan reaffirms our commitment to placing survivors' voices at the centre of our work. Their lived experiences guide our services, shape our advocacy, and drive the change needed to prevent future abuse.

Thank you for your interest and support as we continue this vital work.

Yarning with Aunty

- Knowmore's Elder in Residence





Aunty Glendra (Gallindurra) Stubbs is a Wiradjuri woman. Her mob originates from the Mudgee/Dubbo and Narrandera area.

Aunty Glendra has been with Knowmore Legal Service for more than ten years, and has been Knowmore's Elder in Residence since 2021. She supports the organisation to provide legal advice to the Stolen Generations and to those who have experienced childhood sexual abuse, in a culturally safe, trauma informed way. Aunty Glendra champions the rights and the voices of survivors every day.

For those who have not heard of an Elder in Residence, can you tell us what this position means?

When someone came up with the concept of an Elder in Residence, I thought, what an unusual concept, and now I find out there are Elders in Residence everywhere, so I am claiming to be the first Elder in Residence.

It's about honouring the knowledge we have as older people and the support we give to our young ones. No one is the expert on everything. To be an elder is to be somebody that people can talk to without being judged, and getting advice that is sometimes not what they want to hear. It's given with love and respect.

Aunty Glendra was instrumental in the advocating for an apology to the Stolen

Generations. Aunty Glendra represented NSW's Stolen Generations. We asked her what witnessing the apology means to her.

The Stolen Generations said that they wanted an apology for what happened. They wanted to make sure that it didn't happen again. It was all about making sure that the kids of the next generation would have better opportunities.

It was a really profound thing to be part of. This is like someone walking on the moon. I started sobbing I am really not someone that cries. I thought that this would never happen in my lifetime.

The WA government recently introduced a Stolen Generations Redress Scheme for survivors. How significant is this for survivors from the Stolen Generations?

The Queensland Government is now the only state or territory to have not taken this important step. It's time. Redress cannot undo the harm that was done, but it can provide recognition, some measure of justice. At a national level there are 24,000 First Nations kids in the child protection system across the country. And I think oh my God, the transgenerational pain they are going through is beyond repair. It's no good saying sorry if it's still happening.

There are redress options for Stolen Generations survivors in some states and territories. If you're from the Stolen Generations, Knowmore is a free and confidential legal service. We are separate from government and will keep your information private. We have Aboriginal Engagement Advisors across the country to support you along the way.

"Justice, for me, looks more and more like that shame being stripped away and returned to the people it belongs to," she says.

Warren speaks of the emotional toll of abuse and the long road to peace.

"The major thing I lost when I was 11 years old was



emotions... and love." Years later, he found healing through time, the ocean, and inner strength.

Claim Farming - What You Need to Know

Claim farming is an exploitative practice targeting survivors of child abuse. It involves someone contacting a survivor, often without their consent, and passing on their details to a law firm in exchange for payment. The survivor is then locked into a legal agreement, sometimes without fully understanding the terms, and may be charged excessive fees that reduce their redress or compensation.

At Knowmore, we've supported many survivors who have been approached by claim farmers. They describe feeling pressured, confused, and taken advantage of. For many, the experience is deeply retraumatising.

We believe survivors deserve respectful, transparent, and trauma-informed legal support, not coercion. That is why Knowmore has long called for a national response to stop claim farming and protect those affected by child abuse.

Some states and territories have introduced laws to crack down on this practice, but protections are still patchy across Australia. We urge governments without



safeguards in place to act quickly.

Over the coming months, we will seek your support as we advocate for state governments to introduce new laws to protect survivors from claim farming in every state and territory in Australia.

Our Outreach Program plays a vital role in connecting with victim survivors of child abuse and members of the Stolen Generations in ways that are respectful, culturally safe, and grounded in trust.

Our teams travel across the country—into metropolitan areas, remote regions, and onto Country—to meet people wherever they feel most comfortable.

Every pin on the map below represents more than a place—it reflects our commitment to showing up, listening deeply, and walking alongside people on their journey toward healing.

We're proud of the ground we've covered, and we remain committed to reaching more communities, because everyone deserves support that truly meets them where they are.

What can Knowmore help with?

Knowmore is a free legal service for people who have experienced child abuse, including those from the Stolen Generations.

We were established in 2013 to support people giving evidence to the Royal Commission into Responses to Child Sexual Abuse. Today, we continue to help victim survivors understand their legal rights and options in a safe and supportive way.

Our team can talk with you about:

- Your options for compensation or support
- How to apply to the National Redress Scheme or respond to an offer
- Free referrals to trusted lawyers for civil claims
- Payments available through victims support schemes or other state programs

Our service is free, confidential, and traumainformed. We listen, we explain your options clearly, and we support your decisions—every step of the way.

What Do These Words Mean?

- Civil law claim: A legal process where someone seeks money (compensation) for harm they've experienced. This often involves hiring a lawyer.
- Redress: A formal way of recognising and responding to harm. Some government schemes offer redress without going to court.
- Victim survivor: A person who has experienced trauma, such as child abuse.
- Victims support: Government programs that provide help—such as counselling, financial support, or recognition payments—to people affected by crime.
- Redress Support Services (RSS): Community organisations that can support you emotionally and practically before, during and after applying for redress.
